# Trainer

**Prof Mark Reed** is a recognized international expert in impact research with >150 publications and >13,000 citations. He holds a Research England and N8 funded chair at Newcastle University, is research lead for an international charity and has won two Research Council prizes for the impact of his research. His work has been funded by ESRC, NERC, AHRC and BBSRC, and he regularly collaborates and publishes with scholars from the arts and humanities to physical sciences. He regularly sits on funding panels and reviews programmes of research for the Research Councils.

He has run workshops to help researchers prepare for GCRF funding across the UK in collaboration with the Research Councils and the UK Collaborative on Development Sciences (UKCDS). He worked with cattle herders in the Kalahari for his PhD and since then has done research funded by the EU, British Academy and the United Nations with marginal agricultural communities across the developing world. His most recent book, published by Routledge is based on his work for the UN Convention to Combat Desertification and the UN Framework Convention on Climate Change.

He has been commissioned to write reports and talk to international policy conferences by the United Nations and has been a science advisor to the BBC. Mark provides training and advice to Universities, research funders, NGOs and policy-makers internationally, and regularly works with business.
